I was proud to announce the groundbreaking of Sutter Health's project to reopen the Mack E. Mickelson Arthritis and Rehabilitation Center Therapeutic Pool in downtown San Mateo at Mills Health Center at a press conference I conducted on Saturday, Jan. 6.

As many of you may know, the Mickelson warm water therapy pool is the only facility in San Mateo

County that provides a wheelchair-accessible warm pool specifically designed for therapeutic use by seniors, adults and children with chronic pain or disabilities, patients recovering from surgery, pregnant women, and others who find the warm water healing.

The \$4 million pool opened 25 years ago and was financed entirely by community donations, including \$1.5 million from the late philanthropist Mack E. Mickelson. Plaques on the pool wall also showcase names of donors.

Sutter announced in 2020 as the pandemic started that the pool would be closed permanently. Sutter now plans to reopen the pool in July 2024.

Shortly after the pool was closed nearly four years ago, Lindsay Raike formed the nonprofit advocacy group Warm Water Wellness and coordinated a grassroots effort with the support

of my office to reopen the pool. With her support, I authored a resolution in February, 2022 urging Sutter to reopen the pool that the San Mateo County Board of Supervisors unanimously passed. Special thanks to the Brisbane City Council for adopting the same resolution later that year in October.

Many in need of this warm water therapy pool were told it would close forever but Sutter has listened to the community and is keeping its promise to rehabilitate Mickelson and open it back up to the community in July. It wasn't easy and took a coordinated grassroots effort to make this happen and I applaud the hundreds and even thousands in our community who did not give up, who did not take "no" for an answer.

On May 8 2023, state and local elected leaders joined me in writing a letter to Sutter CEO Warner Thomas asking him to commit to reopening the pool. The letter writers included Assemblymember Marc Berman, Assemblymember Diane Papan, Assemblymember Phil Ting, State Sen. Josh Becker, State Sen. Scott Wiener, San Mateo County Supervisor Noelia Corzo, Peninsula Health Care District Director Dennis Zell, Esq, Sequoia Healthcare District CEO Pamela Kurtzman and Sequoia Healthcare District Director Kimberly Griffin, RN.

This incredible grassroots effort shows the power of our community when we come together and advocate for the needs of our most vulnerable.

TRASH TALK: COLLECTION CART AND BIN REVIEWS

Q: Are the contents of our garbage, recycling and organics bins being observed?

A: Yes. SSF Scavenger staff periodically look under the lids of waste collection carts and bins to ensure that materials are reasonably well sorted. This is done on regular collection days as required by the state mandated outreach and education program. The purpose of this program is to prevent cross-contamination of waste so that we can maximize the percentage of recycled materials and minimize the amount of organic material sent to landfill.

Q: What happens if SSF Scavenger staff observe a problem with our waste sorting?

A: When a problem is observed, an educational notice is left on the offending cart or bin. The notice indicates the problem and how to correct it. Repeat notices for the same offense can result in SSF Scavenger declining to empty the container until the contents are properly sorted. In the case of blatant, repeat offenses, the issue is forwarded to the city. State law requires the city to have in place a process for issuing Notices of Violation and/or administrative citations for noncompliance.

We hope that everyone will see the review and notice process as an opportunity to step up our collective waste sorting game and do more for the planet and future generations. Everyone's efforts are meaningful and appreciated!

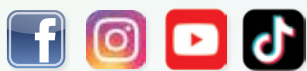

Brisbane's New Business License Processor for 2024

The City of Brisbane has partnered with HdL

to administer the business license program commencing with the 2024 renewal season. Renewal notices went out the first week in January via US mail and via email to those who with an email address on file. The online business license portal for applications and renewals went live on January 2nd, and is available at brisbane.hdlgov.com. For questions about filing or renewing your business license, please contact HdL at brisbane@hdlgov.com or call (415) 240-4471. Their operating hours are Monday through Friday 8 am – 5pm PT.

Any person engaging in business in the City of Brisbane must first apply and receive a business license from the City and pay the business license fee. Any business having its location or mailing address in the City of Brisbane or any out-of-town business operating in the City is required to maintain an active business license with the City of Brisbane.

Second Reading of Dark Skies Ordinance-January 18th

The Brisbane City Council will hear a second reading of the Dark Skies Ordinance at their regular

meeting on Thursday, January 18. A few minor changes were made as a result of the first hearing on November 16. Should the ordinance pass, it will become effective for new outdoor lighting on March 1, with one year to make simple fixes to existing lighting and longer timelines for more extensive changes that may be needed.

BLAST From The Past

The following article is taken from *The Brisbane News Bulletin*, a Brisbane Chamber of Commerce publication, printed December 1946.

Report to The Community From Your Chamber of Commerce

As the year 1946 comes to a close and this month being the second anniversary of the Brisbane Chamber of Commerce, it is only fitting and proper that a full report of Brisbane progress be submitted to its citizens.

Due to the efforts of your Chamber of Commerce under the able leadership of Presidents, Melvin H. Lowe and Allan R. Adams, for the years of 1945 and 1946, respectively, several outstanding projects have been accomplished.

The No. 1 project that we are particularly proud of its the securing of the State appropriation of the \$40,000 to be spent for traffic lights at the entrance of Brisbane, making it much safer to drive in and out of the community. The work will be started as soon as electrical conduit is available.

The second project we are justly proud of and feel the people of the community should appreciate is the "Brisbane News Bulletin," sponsored by the chamber and distributed without any cost to the people of Brisbane. We feel that every citizen should give this project wholehearted support.

Another sponsored project was the compiling and printing of the new city directory which is now a reality and will be ready for distribution in the near future.

Among one of the first projects to materialize was the County Dog Ordinance, which is now on the books of San Mateo County. This ordinance should be vigorously enforced by the people of Brisbane. The Law states that all dogs within San Mateo County must be licensed.

In 1944 the Local Fire District was handicapped for the lack of water. Through the continued efforts of the Chamber of Commerce water committee, who met with the Railroad Commission and the local water companies, the supply of water was considerably increased.

We still believe that the water supply is far short in furnishing the needs of Brisbane and the fire hazards that still exist. True, fire rates have been reduced, yet they are too high. Only through the cooperation of the citizens with the Chamber of Commerce will we be able to further reduce the fire rates and provide adequate water for fire protection.

The Chamber of Commerce approved the original Police Protection, believing

it to be a step in the right direction. Due to recent reports reaching us, we find there are many loop-holes in the present set-up that should be strengthened and corrected. Will the people of Brisbane help to make our Police Force a permanent thing by forwarding their suggestions to the Chamber?

You should support your local Chamber of Commerce. Any community is more progressive with such an organization. It carries prestige and dignity to any up-and-coming town. If it had not been for the Chamber of Commerce, all the above would still be in the far future.

Therefore, on our second anniversary, we take pride in renumeration our progress this far: A State appropriation of \$40,000 for traffic lights; The "Brisbane News Bulletin;" A City Directory; County Dog Ordinance, More water for fire protection; Lower fire insurance rates. All accomplished in the last two years.

GIL'S DRUGSTORE

Gil's Drug Store, was one of a kind. It was a variety store, medicine and prescription store, small five and ten cent store also a meeting place for Brisbane residents. This humble, small wooden structure at 49 Visitacion, (painted fire plugs are there now) had two windows in the front and customers entered by opening a screen door. Gil was a wise, kind, and intelligent pharmacist, residents loved him. He also served as Brisbane's first police commissioner. Gil's glasses were always on the tip of his nose and he wore a rumpled wrap around tan apron, like grocers used to wear. "Gil" Gillman's drug store was constantly busy, a social gathering point where residents visited, received free information on most any subject, advice for their ailments and oh yes, he did fill prescriptions! The store was heavily cluttered with boxes and in a constant state of disorder. Customers were used to it being that way and no one complained.

I could see only a part of the top of the soda counter, a beautiful swirled colored marble, but it was piled high with boxes, supplies and papers!

Sticking up behind the counter top, were the high chrome shiny soda pumps. I never saw anyone sipping a soda or enjoying a dish of ice cream!

Scattered tables in the store hosted a variety of cough syrup bottles, bobby pins, hair tonic or Duncan Yo-Yos, and more, creating a continual hunt for wanted items. When a customer had to ask for an item, surprisingly, Gil knew where everything was to be found in the store! The residents relied on him for their information, medical or personal advice. I remember one time he told me for exercise don't walk on level ground, walk on uneven soil. Dr. Guardino, our much loved town physician and Gil were very close friends. At times they could be heard arguing in the store. Dr. Guardino had to remind Gil constantly, in a pleasant way, that HE was the doctor!

Early Thanksgiving morning in 1949, it was sad and heartbreaking sight. Residents found flames shooting from the roof and front windows of Gil's store. Volunteer firemen rushed to extinguish the blaze, but the unique drug store was a total loss because of poor electrical wiring. Gil had cancelled half of the expensive fire insurance two weeks before! He soon opened another drug store in the Bayview district of San Francisco.

After the fire, a young pharmacist opened a new drug store up the street. He wore a starched white jacket and on display in shiny new glass cases were a lovely variety of gifts for sale. Stock on the shelves and on the counters was all neat, clean and in perfect order. There were no tables to be found in the new store!
