# WINE DOWN THE YEAR WITH TALA WINE CO

Popping champagne to celebrate the New Year and toasting friends and family across the table on Christmas Eve are just some of the few ways wine is synonymous with the holiday season. This year, consider stocking your bar with wines purchased from right here in Brisbane. That's right, Brisbane is home to Tala Wine Co, an online wine company that specializes in natural wines.

Founded by Brisbane resident Tala Drzewiecki, Tala Wine Co offers a monthly wine club with a range of price points, bottle amounts, and delivery frequency. Tala chooses each wine for every subscriber based on what she thinks they will enjoy. She consults with the customer for feedback and develops a highly customized profile for each individual's wine preferences. This careful attention sets Tala Wine Co apart from other wine clubs. No other subscription models have the same concierge

directly from her inventory. Wine matchmaking has become her super power. If subscriptions aren't your thing, you can purchase by the bottle too. Bottles cost around \$35 on average. If you're unsure what to buy,

style, high-touch customer service experience.

While most websites rely on algorithms to predict

what a customer will like, Tala selects wines

guesswork. The box comes specially curated by Tala with wines that pair well with holiday meals. Priced at \$175, the holiday pack contains an assortment of sparkling, red, white, and rosé wines. There's something for everyone. Keep a few for yourself, gift one, and bring a bottle to a holiday party.

If you prefer to dip a toe in with one bottle, Tala recommends the 2020 Montesecondo Loupé Rosso for those who like red wine. A Chianti-style wine from the Tuscany region in Italy, this one is medium-bodied with notes of earth and red fruits. It pairs perfectly with tomato-based pasta and roasted vegetables and is \$26. Those who prefer white might enjoy the Tala Wine Co's holiday six-pack takes out the 2020 Dominique Gruhier Tonnerre Bourgogne Blanc.

Tala describes this as "a classically-styled white Burgundy wine made from 100% Chardonnay aged in French oak. It pairs nicely with various kinds of cheese, salads, or roasted chicken/pork." This one is organically farmed and priced at \$28. Another incredible white wine they offer is the 2020 Unturned Stone Chardonnay from Mendocino County. Tala calls this wine "transcendent" and the "best California Chardonnay I've had in my life." Pick up a bottle for \$44.

If you're curious about Tala Wine Co's inventory, their website can be searched easily with filters by grape, region, production practices, price, and type of wine. They have wines from all over the world, including Chile, France, Hungary, Italy, Slovakia, Spain, and the U.S. All wines are natural, which is at the core of Tala Wine Co's focus. They classify natural wines as wine fermented with ambient/native yeast, minimal or no SO2, no other additives, unfined/unfiltered, and organically farmed. In most cases, the grapes are grown with few agricultural products such as fertilizers.



While additive-free wine may have a bad reputation, Tala insists that the quality of the wine has dramatically improved over the last decade. The shelf life of natural wine is comparable to regular wine and what many don't realize is that all wines produced before the 1960s were natural wine. Wines sold in the United States aren't

required to list their ingredients, so consumers have no idea which additives they may be consuming. Tala explains, "I seek out producers who are transparent about their farming and production practices. Wines made naturally are not only better for the planet and consumers, but are more soulful, enjoyable, and have a greater sense of place."

Tala's journey into the wine space and calling Brisbane home are intertwined. Tala moved to Brisbane in 2009 when she relocated here because of her job at Sierra Point, working for IGN. Initially, she had commuted from Oakland on her motorcycle but soon fell in love with Brisbane and decided she wanted to move here instead. In the garage of her home, she began a wine-making hobby and learned everything about the process. In 2013 she left her job in tech and started Winelandia, her first online wine store and wine club, while also working at a small wine shop in Potrero. During this time, she hosted regular wine tastings and large-scale wine events and her passion for natural wines grew. Around 2015-2016 one of her vendors, Adventures in Wine, located near 7 Mile House, offered her a job. With so many irons in the fire, she sunsetted her first online wine shop. However, in 2020 the pandemic motivated Tala to open her online wine business again, and Tala Wine Co was born.

# **CAPITAL PROJECTS** CHARGE REFLECTED ON UTILITY BILLS IN LATE DECEMBER

The City Council voted to implement the second of four Capital Fee Charges for the Utility Fund on October 6, 2022, which are being phased in over a 17-year period to pay for improvements to:

- The City's aging water and wastewater systems such as an Advanced Metering Infrastructure (AMI) system that will provide improved operational efficiency and allow customers to view near realtime consumption data and potentially save costs by way of leak detection availability
  - The Glen Park Pump Station upgrade
  - Ongoing water and sewer pipeline replacements

The cost of these projects above is \$10,000,000. The rates are graduated based on springtime usage (mid-February - mid-June) which ensures lower water users will pay less than higher users. See the City's website for the actual rates at brisbaneca.org/ capital-projects-charge. Utility customers should see this second Capital Fee Charge for the Utility Fund issued in December 2022.

The City of Brisbane Offers a Low Income Rate Assistance (LIRA) Program for Utility Bills

The Low Income Rate Assistance (LIRA) Program is offered to current City of Brisbane Water & Sewer customers who are enrolled in PG&E's Care Discount Program. Once a customer is enrolled in the LIRA program, discounts will go into effect starting the next billing period.

To enroll in LIRA, a customer must provide the City of Brisbane a current copy of a qualifying PG&E bill that:

1. Has a name and service address that matches the name and service sddress on the Brisbane Utility Account

2. Indicates the customer is currently receiving PG&E's CARE Discount Customers can apply for PG&E's CARE discount program and/or find out if you are eligible at <a href="mailto:pge.com/CARE">pge.com/CARE</a> or by calling 1-866-743-2273. For questions about the City of Brisbane LIRA Discount Program, please contact the City of Brisbane Utility Billing Department at (415) 508-2154.

#### Nov. 8th Official Election Results

The City Council at their special meeting on December 9th adopted resolutions certifying the County's results of the November 8th Municipal Election. This included the County's Certification of Votes declaring the results of Measure O and U at the Municipal Election held November 8th.

As a reminder, "Measure O" is a business tax on those who provide lodging accommodations such as hotels and short-term rentals. "Measure U" is a district Transaction and Use Tax. Also at their special meeting, the Council adopted ordinances to implement the new taxes. All ordinances require a second reading, which, for these two are scheduled to go on the agenda for the December 15th City Council Meeting. If adopted, the taxes will go into effect 30 days later (the first remittance for Measure O – covering January 1, 2023 through March 31, 2023 – will not be due until April 2023).



### DON'T OVERLOOK IMPORTANCE OF CASH

If you're an investor, you no doubt pay a great deal of attention to your stocks, bonds and mutual funds. But you shouldn't forget another key element of your financial strategy: cash.

Cash is part of any financial strategy and investment portfolio, but how much have you thought about the different uses of cash, and how much you really need? Consider these four key purposes:

- Unexpected expenses and emergencies If you face an interruption in employment, you need an extensive home repair or you encounter an unplanned medical expense, you may need access to cash. If you're not retired, it's a good idea to have three to six months of living expenses in cash, possibly supplemented by access to a line of credit. If you're already retired, keeping up to three months of living expenses in cash, possibly supplemented by a credit line, is a good rule of thumb.
- Specific short-term savings goals You may have some goals you want to meet within the next year or two, such as a wedding, a vacation or the purchase of a new car. And since you have a little more time to meet these needs than you would for an emergency, you might consider using a money market account or a short-term certificate of deposit (CD), in addition to your other savings vehicles.

### TRASH TALK-SORTING SMART IS REQUIRED

**Q:** Is it true that the State's requirement to sort organic waste from landfill-bound garbage will be enforced in Brisbane starting next month?

**A:** Yes. Starting January 1, 2023, Brisbane's code enforcement team can issue citations for placing organic waste like clean paper and cardboard, food scraps, food-soiled paper, and yard trimmings in the garbage. They can also cite for placing garbage in a recycling or organics bin. SSF Scavenger and City staff are working to avoid the need for citations. The goal is to encourage everyone to sort waste correctly so that we minimize what is sent to the landfill and maximize what we recycle and compost. reduce spending to free up funds for investing in long-term goals. If you're still working, keeping one to two months' worth of living expenses in a liquid account may be sufficient, but if you're retired, you may need up to 12 months of living expenses, which you can adjust to accommodate outside sources, such as Social Security or a pension.

• **Source of investment** – You can look at cash as an investment source in two different ways. First, cash can be considered its own distinct asset class, and because it typically behaves differently from other asset classes, it can provide some diversification to a portfolio containing stocks and bonds. (Keep in mind, though, that diversification can't guarantee profits or protect against all losses.) And second, the cash in your portfolio could be used as part of a systematic investing strategy in which you put set amounts of money at regular intervals into investment vehicles that are appropriate for your goals and risk tolerance.

Clearly, cash is an important part of planning for the future, but there can be too much of a good thing. While cash may seem like a perpetual safe harbor from the stormy investment seas, it is not without risk. If you hold too much cash, you could underfund your longer-term investments — the ones with the growth potential you need to reach some of your most important goals, such as a comfortable retirement.

Put your cash to work. By using it wisely, you can add a valuable element to your financial picture.
