# **PROTECTING A WOMAN'S RIGHT TO CHOOSE**

As the Supreme Court may overturn the landmark Roe v. Wade case in June or July, state lawmakers and local officials such as myself are looking to not only protect but to expand protections for women to seek safe abortions.

Currently, my office is looking to create a buffer zone around the Planned Parenthood clinic in unincorporated Redwood City. It would create a

Vitalant, the "nation's largest independent, nonprofit organization focused exclusively on providing lifesaving blood services," moved its headquarters to Brisbane about three years ago. Founded in 1941 as Irwin Memorial Blood Bank. the organization was the first community blood bank in the United States. In 1997 Irwin Memorial Blood Bank merged with Peninsula Memorial Blood Bank and rebranded as Blood Centers of the Pacific. After a merger with Sacramento's BloodSource in 2015, the nonprofit rebranded with the name, Vitalant.

Today, Vitalant hosts 100 community blood drives a month, operates six donation centers, and collects blood from 1000 donors a week. Vitalant serves over 45 Bay Area hospitals, being the sole provider of lifesaving blood to local patients in need, according to Kevin Adler, Vitalant's Communications Manager. Vitalant hosts regular monthly blood drives at its headquarters in Brisbane at 400 Valley Drive and is always looking for businesses to sponsor a drive. Sponsoring a blood drive is simple. Vitalant provides all the marketing materials a company needs to communicate to employees how to participate in the blood drive. On the date of the drive, donors will give at Vitalant's location, so there's no need to set up in a company's parking lot or conference room. All a company must do is encourage its employees to donate. The entire process takes about an hour, although the actual giving blood part is only about ten minutes. Giving blood is a cost-free act that can save the lives of up to three people, Kevin explains. Donated blood gets divided into three componentsred blood cells, platelets, and plasma, and each can go to a different individual. All blood types are constantly needed, which Kevin predicts will only grow stronger as most of their consistent blood donors are boomers. Boomers are aging out of giving blood and are not being replaced by younger

donors who give consistently. The pandemic has also impacted blood supplies. Businesses and schools that hosted drives suddenly were unable to as students and employees worked from home instead. Vitalant urges that anyone able to donate blood do so whenever they are eligible.

Vitalant tests all blood donations for COVID-19 antibodies (through mid June 2022) so that the immunocompromised and those fighting the virus can receive plasma that can help them. This process is called convalescent plasma therapy, in which the antibodies from someone who has recovered from COVID or who has had the vaccine can help someone else recuperate.

While many people assume blood donations are for those who have suffered from tragic accidents, Kevin explains that many patients, such as those battling cancer, require regular blood transfusions as part of treatment. Kevin tells me the story of Annie,

a little girl saved by Vitalant blood donations. A few weeks before her fourth birthday, Annie's parents noticed she was sick and behaving unlike herself. Doctors diagnosed her with a blood and bone marrow cancer called acute lymphoblastic leukemia. Annie's treatment required her to have multiple blood and platelet transfusions. Without them, she likely would not have survived. Annie completed chemotherapy and recovered from cancer. Now her parents advocate for people to donate blood on a regular basis so that children

SafeTREC program will be partnering with Brisbane to do an assessment of Bayshore. Their team will focus on areas of bicycle and pedestrian activity, particularly from Old County to the Mobile Home Park. And none of this will cost Brisbane a dime.

Later this summer or early fall we'll have their suggestions; some may necessitate changes to the roadway itself. That's where it will start costing money. And yes, we'll be looking for some of those federal infrastructure dollars you've been hearing about.

Previous traffic studies told us that about 20,000 cars travel on Bayshore through Brisbane on a daily basis. That's a lot of cars, but could be even more by now. Roughly 70% of the cars are non-residents while 30% are residents coming and going from home.

Fortunately, I've noticed our Brisbane Police stopping quite a few cars speeding or blowing through stop signs.

safe space to protect a woman's privacy as they seek reproductive health care in a safe setting. Protests have increased around such clinics and hopefully the policy the county enacts can be a model for our cities to follow.

With a continuing assault on women's reproductive rights, we've seen an uptick of protests at clinics such as the Planned Parenthood located on 2907 El Camino Real on the edge of Redwood City.

Therefore, I agree with the Redwood City Council that the county should create a buffer zone around this clinic to protect the privacy and rights of the women who are seeking reproductive patient care. In fact, I think the county should work with our cities to create buffer zones at every health clinic in the county that provides reproductive health care. No woman should be in fear of caring for her own body by seeking health care at these clinics.

We are also looking to declare the county as a "Pro Choice Sanctuary" for women across the country and to provide resources for women who may be forced to seek abortions out of state.

In other news, the Board of Supervisors recently approved a permanent living wage ordinance for all government contract workers, for profit or nonprofit, to \$18.61 from \$17.79 an hour starting July 1. In San Francisco, the wage will increase, for-profit contract workers only, to \$19.15 from \$18.55 an hour starting on the same date. By contrast, Marin County's policy approved Jan. 1, 2022 requires county contractors and subcontractors to provide \$16 an hour up from \$15.40 the previous year.

As we live in the wealthiest counties in the nation, we must provide government contract workers, who are critical partners, with a living wage if we want to attract and retain a quality workforce that provides services our counties do not.

# TRASH TALK

#### **Q:** Any tips for hosting a waste-free party?

A: Whether it's for dad, grad, or just because, preplanning is key. Start by getting a head count and not providing more food than necessary. If you think there might be leftovers, ask guests to bring reusable containers to fill and take home. Provide food and drink that don't create unnecessary waste. Serve finger foods (tacos, hot dogs, hamburgers, pizza, corn on the cob, watermelon, grapes, cupcakes, etc.) that don't require utensils and maybe not even a plate. Serve beverages from bulk containers instead of single-serving cans and bottles. If you need plates, utensils, and cups, plan to use reusables. You can bring them from home, have guests bring their own, or you can rent them from a variety of Bay Area businesses. Finally, be sure to have collection bins set up for guests to sort any waste they do have. Put clear signs on the bins so that even out of town guests know what belongs inside.

# Q: Can I put disposable forks, knives and spoons in the recycling?

**A:** No. If they are plastic, even the type sold as compostable, they belong in the garbage. The only exception would be wooden utensils which can be composted and belong in a green bin.

#### **Case of the Lost Matches**

Brisbane Police proved last week it doesn't just happen on television.

Police Chief Bill Beard this week took time out to relate a story which sounds more like a script to a "who-dunnit" rather than a drab police report.

It all began with a burglary on February 22-Washington's birthday no less. Ralph Cole, of 462 Alvarado Street, phoned police to report that his home was burglarized of \$2000 worth of rare and foreign coins along with a small safe.

When Police Chief Bill Beard arrived, he found that the front window had been forced open to gain entrance. It appeared to be another modern day hit and run burglary, with few or no suspects.

But a tooth-combing of the residence produced two matchbooks which did not belong to the homeowners. Armed with these, Chief Beard consulted with his officers and came up with the name of a possible suspect who had been involved in past burglaries.

Beard then checked the residence of the 15-year-old suspect, and talked with the suspect's mother who immediately identified the matchbooks as belonging to a brother-in-law's out of town store.

With the cooperation of the mother, Beard was able to fit some of the pieces together. By checking with the schools, Beard discovered the youth has cut school on the 24th to purchase \$50 worth of new clothes.

About this time during the investigation Beard discovered there was an accomplice in the burglaries, a 30 year old San Francisco man, who had spend the 22nd with the suspect.

"We also had witnesses who placed the suspects in the area of the burglary that day,"Beard said. This second suspect had also purchased clothes on the 24th, \$300 worth of them.

It took approximately one week for Beard to compile the information from his investigation and to get warrants for the two suspects. He was ready to make the arrests last Tuesday, and he did so smoothly, at least with the juvenile.

Beard related that the juvenile was arrested at 4 pm Tuesday after school let out. "I was here until almost 8 pm booking the suspect," Beard recalled, adding that the suspect was noncommittal about the burglary, "he didn't admit to it nor did he deny it."

"I had a school board meeting at 8 pm and then I headed to a city council meeting which ended at 10:20pm. As I was walking towards my car I saw the second suspect driving up Visitacion," Beard reported "and I pursued him to Bayshore and Mission," where he arrested Galvin Thompson, 30 years old, of San Francisco.

Beard reported that Thompson admitted to breaking open the safe which was stolen in the burglary but he did not admit to the burglary itself. "He admitted to opening the safe after we found a roll of rare bills which were stolen in the burglary," Beard said.

Thompson does not have a previous burglary arrest record but the Brisbane juvenile has been previously arrested for burglaries in the city. Thompson was taken to the San Mateo Sheriff's department while the juvenile was taken to the Hillcrest Juvenile Authority in Belmont.

Beard says about 20 percent has been found in different sports throughout the city. "We found some money with the safe on the Guadalupe canyon road and found some more in different hiding spots in the city," Beard said.

But the real loss is not just the money spent on clothes but that it was valuable money. "Usually they just pass it over the counter as regular money," Beard commented.

## FINANCIAL ISSUES FACING WOMEN BUSINESS OWNERS

As a business owner, you're always busy, so it's understandable if you've put off thinking about events that won't occur until far in the future – such as your retirement, the sale or transfer of your business and the settling of your estate. # EVERYTHING OLD IS RENEWED AGAIN

Baylands Development Inc. (BDI) is pleased to announce the completion of its renovation of the historic Schlage Lock office building which will serve as the site of BDI's new headquarters. Located in Visitacion Valley, at the corner of Bayshore and Blanken, the iconic office building is the only remaining structure of the old Schlage factory.

BDI meticulously restored this historic 1920s office building to its original grandness and will serve as its headquarters and essential anchor for The Baylands and the neighborhood. The building renovation involved removing and restoring the roof's original clay tiles, sourcing new windows to mimic the historic window frames, and modernizing the building's utilities for energy and water conservation and efficiency.

Making the old Schlage Lock office building BDI's new headquarters was a

significant undertaking and not something the company took lightly. Given the expansive viewshed from the historic building, the new headquarters provides BDI with a bird's-eye-view onto the entire Baylands property and places it closer to its neighbors and the community. As provided in the development agreement with the City of San Francisco, BDI's commitment is to provide 25% of the building space (approximately 5,548 square feet) for community use. BDI is meeting this commitment and has designated the historic office building's ground floor for the community space, complete with kitchenette, restrooms, and a private entrance that can be used during non-business hours and direct access to the outdoor plaza.

BDI expects to move into the new space in the very near future, so look for an open house invitation soon!




