LUNAFEST GOES OUT WITH A BANG! By: MADISON DAVIS, City of Brisbane Mayor,

LUNAFEST, a film festival featuring short films by, for, and about women, came to Brisbane this past weekend for the fifth time. The festival, created by CLIF Bar in connection with their women's health bar, Luna Bar, aims to illuminate the gender inequities in the film industry and provide a vehicle for women to tell stories often left untold.

While women constitute 50% of the moviegoing audience, of the top 100 grossing films in 2022, women represented 11% of directors, 18% of editors, 17% of writers, and 28% of producers. And if you think these numbers are dismal, there has been minimal improvement in the last 25

The tobacco epidemic is not just a statistic, it's a tragedy. It's robbing us of millions of lives every single year, including our youth. We must take a harsh stand against this deadly addiction that has killed more than 8 million people a year!

In response, the San Mateo County Board of Supervisors May 9 passed one of the strictest

1 in 2 lungs, 1 in 3 hearts, and 1 in 5 kidney transplants are expected to fail within 5 years, primarily due to rejection by the patient's immune system. In the United States, it is estimated that seventeen people die daily waiting for an organ, as more than 100,000 people wait on the organ transplant waiting list. Organs are too precious to fail so frequently and quickly after transplant. CareDx wants to change the odds.

Founded 20 years ago, CareDx is the only transplant diagnostics company 100% committed to serving transplant patients and the ecosystem surrounding organ transplants. CareDx offers support pre and post- transplant of the heart, kidney, and lungs. Its core business focuses on providing clinicians with critical information that can help determine if a patient is a candidate for a transplant and, once they have received an organ, prevent it from being rejected by the body. This information increases survival rates and helps preserve organs from damage because clinicians can better determine when and how intervention should occur before it's too late.

In the early days, before CareDx, doctors would monitor patients through a tissue biopsy which required an invasive procedure, sometimes with anesthesia. However, biopsies are often lagging indicators of a problem, meaning doctors could miss early signs of rejection. In 2005, CareDx introduced the first non- invasive blood test to measure the immune status of a patient after receiving their heart, AlloMap and in 2018, introduced HeartCare which includes AlloSure Heart. Together, these tests can determine if the heart is at risk for rejection and has helped nearly 30,000 heart transplant patients to reduce pain, anxiety, and risk caused by biopsies. These tests helped save San Jose resident Eddie Garcia from heart rejection. Doctors noticed troubling results and had him come in for treatment. Due to early intervention, Eddie now exercises by walking four miles daily with no heart issues and has written a book about his survival called "Summer in the Waiting Room."

Patients who receive a transplant must take several medications for the remainder of their life. These medications suppress the immune system but can also be toxic to other organs like the kidney, explains Anna Czene, VP of Corporate Communications for CareDx. "If a patient responds well, a clinician may pull back the drugs, or if the body shows signs of rejection, they can increase medications," says Czene. CareDx aims to give clinicians the critical information they need to make life-saving decisions.

In 2017, CareDx launched AlloSure, a blood

a part of you, including the cells in the kidney," explains Nikhil Agrawal, MD, Medical Director of Kidney Transplant at CareDx. The immune system allows the body to determine which cells belong and which are invaders. Because transplanted organs come from others, they contain foreign cells and signal a threat to the immune system, and the body fights the new organ. The best way to prevent rejection is through immunosuppression. According to Dr. Agrawal "Many rejections are not severe, and a person doesn't have symptoms they would notice. They may only know from monitoring tests that indicate a problem."Therefore, tests like AlloSure are critical to monitor for signs of rejection.

The company also offers digital health solutions such as TxAccess, a unifying software to help patients navigate the waitlist process by ensuring they have all records up to date so that when an organ is available, they are ready to receive it. In some cases, organs are available for transplant, but a patient's medical record is not in order, making them ineligible. TxAccess facilitates communication between transplant centers, nephrology practices, and dialysis facilities. According to CareDx's website, with the software, "providers can submit referrals and required documents to transplant programs and view the latest information about all their referred patients."

After a transplant, clinicians use CareDx's digital health solution, AlloHome, to monitor patients remotely. Clinicians can track patient vitals and can quickly determine if they need to come in for further testing or assessment. Other digital solutions, like the AlloCare app, help patients track their medications. Transplant patients may take upwards of 30 medications daily, each with instructions, which can be confusing and hard to manage. Failure to take medications as prescribed contributes to organ rejection.

This test is a quick, non-invasive way to see the health of the lungs or kidneys after transplant. Consistent monitoring is imperative because the median age of a transplanted kidney is only ten years. Since then over 100,000 patients have been testing using AlloMap and/or AlloSure.

"All body cells carry a special signature of the person indicating that they are healthy and are

years. In its 95-year history, only three women have won an Academy Award for best director, and only eight have received nominations.

And those statistics are just behind the scenes. Of the top 100 grossing films in 2022, only ten films featured a woman over 45 years in the lead role compared to 35 men in the same age bracket, which is 3.5 films starring older men for every one starring an older woman. Only 16 of the top 100 films featured a woman of color as the lead or co-lead in the story. In 2022 women made up only 37% of speaking characters, and 80% of films featured more male than female characters. Female protagonists are most likely to be featured in horror movies, followed by dramas, and action features.

When women were directors or writers, females comprised 56% of protagonists. In films with exclusively male directors and writers, only 23% of protagonists were women. With women underrepresented in the film industry, our mainstream media fails to showcase enough female-driven stories, especially those featuring the experiences of women of color. Women are too often depicted in movies through the lens of men, meaning there are many missed opportunities to tell stories about women with more authentic representations of the female experience.

Along with promoting female filmmakers, LUNAFEST provides a mechanism for hosts to raise money for women's causes. When I decided to bring LUNAFEST to Brisbane with the support of my council colleagues in 2019, I knew the money we raised needed to stay in town. The Lions Club has always had a presence in my life, and when I needed their assistance most as a college student, they ensured I had funds for my education. It seemed only fitting that the money raised from LUNAFEST should go to the Lions. Thankfully, they shared my vision and have used the funds from LUNAFEST to create scholarships for women pursuing degrees in male-dominated fields such as film, engineering, science, math, technology, political science, or the trades.

When I approached the Lions, they asked me, "How much do you think we can raise?" I said, "I'm pretty confident we can raise \$4000." Fast forward five years, and we have raised over \$150,000 for students.

This year our event generated \$34,605. For context, the average LUNAFEST screening raises \$5,000. Since hosting LUNAFEST in Brisbane, we have maintained a five-year streak as the highest-earning LUNAFEST host worldwide.

Unfortunately, this LUNAFEST will likely be our last. In 2022 Clif Bar sold, and the new owners have decided to end the 2023 LUNAFEST season abruptly at the end of this month. They have no plans for a 2024 season. I hope Clif Bar will reimagine LUNAFEST or that the Clif Family Foundation will continue on the LUNAFEST legacy with another festival but can't say what the future holds. I can say that the Lions and the City will work together to fill the gap left by LUNAFEST with another event.

Every dime raised from sponsorships, concessions, and ticket sales goes directly to students. And what I think is important to note is that due to the influx of funds from LUNAFEST into the Lions Club Scholarship program, the money available each year to award has significantly increased. Not only has the amount available to women applicants increased, but that awarded to men has also. So the moral is when women win, we all win.

I must acknowledge all the people who planned LUNAFEST. The LUNAFEST committee includes Councilwoman Terry O'Connell, Former President of the Brisbane Lions Club Sharon Boggs, Recreation Director Noreen Leek, Park and Rec Commissioner Frank Kern, Park and Rec Commissioner Leesa Greenlee, Park and Rec Commissioner Tom Seawell, Head of the Brisbane Lion's Club Scholarship Committee Deb Horen, and Admin Management Analyst Angel Ibarra. Thank you to all the Lions Club members who worked hard at the event and for being incredible partners in this journey.

At the April 20th City Council Meeting, the Council voted unanimously to approve Resolution 2023-17 increasing the charges for water and sewer services and setting the discount rate for the City's low- income rate assistance (LIRA) plan at 25% for all services. The City spends approximately \$40,000 each year from the City's General Fund for the LIRA program. See if you qualify for LIRA at <u>brisbaneca.org/lira</u>.

The new rates go into effect June 15th, so customers will see the change on their August bill (which captures the June 15 – August 15 billing cycle).

Utilities participating in the State's Low Income Water Assistance Program (LIHWAP) – which the City is one – have raised the maximum benefit for LIHWAP Arrearage Assistance from \$2,000 to \$15,000. More information can be found at <u>csd.ca.gov/waterbill</u>.

anti-to tobacco ordinances in California to combat this epidemic by imposing stiff fines to retailers who sell tobacco products to children or banned products such as e-cigarettes and flavored vape cartridges.

Big Tobacco has preyed on our youth with flavored products like bubblegum and cotton candy for years. The ordinance is a message to our retailers that if you are caught selling to minors or selling banned flavored tobacco products you will be fined heavily.

Because we know tobacco is a highly-profitable killer, the county will now conduct two mandatory compliance checks every year at every retail establishment that sells tobacco products. This is another huge step toward saving lives and change on their August bill (which captures the June 15 – August 15 billing cycle). creating a world free from harmful tobacco products that are purely poison.

The improved public health safety standards in this ordinance give me hope that we can finally turn the tide against the tobacco industry's hold on our communities. For every life lost to tobacco, there's a family and a community left devastated by the loss. We owe it to them to keep up the fight against this deadly addiction.

Every single time a retailer sells a prohibited tobacco product, they are contributing to the tobacco epidemic and putting many lives at risk. We must hold them accountable and demand better for our communities.

The new ordinance restricts where new retailers may be located: no new Tobacco Retailer Permit will be issued to a location within 1,000 of a YouthPopulated Area, or within 500 feet of a location already occupied by another tobacco retailer. "Youth-Populated Areas" is updated to include college campuses.

It also increases fines up to \$500 for the first violation, and up \$1,000 for all subsequent violations within a 60-month period and requires that a permit be suspended if a business is found to have sold tobacco products to persons under the age of 21.

This is about public health and keeping Big Tobacco products out of the hands of children. Enforcement must be prioritized if we want to reach the ultimate goal of having a tobacco free San Mateo County.

needed to find the best space to accommodate our existing workforce." CareDx decided to move to 3260 Bayshore Blvd in Brisbane. A few employees had been eyeing the building for several years and were quite pleased it was available. The building holds its clinical lab and processes all tests. "We love Brisbane because we have a beautiful location. I have a view of the Bay from my desk. Being in Brisbane is perfect because we are surrounded by the biotech community in the area," says Czene.

On the horizon for CareDx is harnessing the power of AI to look at risk outcomes and detecting trends in blood to predict the likelihood of failure. The company also plans to create tests for other organs like the liver. In addition, CareDx is excited about driving innovation for stem cell transplantation on how that might help cancer patients.





BLAST FROM BRISBANE'S PAST

The following article is from the December 28, 1972 issue of the *Brisbane Bee-Democrat*

Year of Decision for Brisbane

Brisbane is facing "probably the most critical year in its history" since the city was incorporated 11 years ago, predicts City Manager Gene Aiello.

"It will be decided whether she really moves forward vigorously, stands still, or just withers and disappears," Aiello said, closely tying in the future of San Bruno Mountain with that of the small rural community nestled in one of its slopes.

Although Brisbane ranks third in a recent report to San Mateo County's Local Agency Formation Commission (LAFCO) about spheres of influence, Aiello is optimistic.

"Things look pretty good," he said. "I think LAFCO will recognize we have the best claim to Crocker Industrial Park and the mountain, and the most logical decision would be to place these areas within our sphere of influence."

Such a decision could cut the tax rate up to one half for the first year after annexation and for years thereafter. But, Aiello pointed out, annexation of any kind won't be completed until 1973-74, and "nothing will be finally accomplished before 1974."

LAFCO's decision on the report is expected early next year.

Concerning the report's first recommendation to merge Daly City and Brisbane for annexation purposes, Aiello stated Brisbane "simply won't stand for it."

"There is no sentiment whatsoever in this community for the merger suggestion," he said. "And nobody can shove it down our throat."

The second recommendation, which assigns the area in question to Daly City, would "severely cripple Brisbane," Aiello warned. The city would lose the \$100,000 a year it now receives for the police and fire protection contract with the Guadalupe Valley Municipal Improvement District (GVMID) and thus be forced to substantially raise its \$1.24 tax rate.

"But I don't think all this will happen," Aiello assured. "Up until now, nobody has taken us seriously. But during the last year we have established the ground fairly well to annex the park and the mountain. Crocker wants us, and the merger recommendation to LAFCO went a hell of a long way in unifying this community."

He warned, however, any type of annexation will be controversial "unless this community further crystalizes its feelings." "Whatever happens," he said, "will be largely what this community wants to happen. We therefore need critical and unemotional study, discussion, and examination of the issues, and of the assets and liabilities of each course of action"

With Brisbane's life "pretty much in balance," Aiello expects the tax rate to remain the same, at least for 1973. "I don't think we can raise it even if we wanted to," he said.

No tax increase above the level of this fiscal year is allowed under the just passed Reagan-Moretti tax reform and school aid bill (SB 90), either without a vote of the people or other conditions not likely to occur in Brisbane in the near future.

Revenue sharing will net the city about \$40,000 during the coming year, and the city manager has "some ideas about how to further increase the revenue base."

He would not divulge the details at this time, however.

Aiello hopes for a state planning grant should Brisbane require professional planning services to work out the particulars of annexation. For this, the staff needs not necessarily be increase, he said, as it can be done on a contractual basis.

With the work on the water improvement system about to begin, Aiello now plans to look into the possibility of applying for another HUD grant to improve the sanitary sewers and storm drains which, together with street work, constitute the city's next priorities.

The grant will depend on Brisbane's financial ability to share the cost, and the availability of categorical grants in general, be explained.

Work on the water system will begin right after the January 1 unless bad weather continues to delay the project. It will be completed by late summer.

The city engineer's first job in 1973 will be to coordinate the street improvement program. The extent of paving and repair is not known at this time, but Aiello said, "weplan to get the maximum use and leverage out of under-grounding and backfill involved with the water system project."

Plans to improve Old Bayshore are being worked on right now, Aiello said. Under a program with San Mateo County and the State Division of Highways, the entire length of the road will be repaved, striped and lighted. Traffic lanes will be rearranged, and the traffic signals improved wherever indicated.

Scheduled to be completed at the beginning of summer, work should start sometime this spring.

"We got quite a bit done last year," Aiello concluded, "and because of extensive preparation undertaken in all these areas, we can look forward to fairly good 1973."

THE BAYLANDS - RESTORATION OF ICEHILL HOUSE

In last month's edition of the Luminary, we wrote about the release of The Baylands Specific Plan and how it will guide the reimaging of the former industrial site. This month, we are diving into the specifics of the document and providing a snapshot of our plans to restore the existing IceHouse Hill open space.

An accessible and interwoven open space system is central to The Baylands Specific Plan. This network consists of diverse open area typologies that serve various recreation needs in the Brisbane community which includes the restoration of IceHouse Hill, a large habitat- focused area nestled between Bayshore Boulevard, the Caltrain tracks, and Main Street.



Design for the future 24.3-acre IceHouse Hill Park will enhance its ecological functions by protecting and improving existing native grasslands, coastal scrub, and small pockets of seasonal wetlands. Icehouse Hill is outside the project's remediation areas, and it is practically the only portion of the property with natural soils, which will help support its more natural character and habitat value by restoring impacted vegetation with invasive species management and the planting of native butterfly host species to increase butterfly habitat extent and quality.

IceHouse Hill Park will provide contemplative recreation for Brisbane residents through passive programming, such as native gardens, butterfly gardens, overlook(s), multi-use trails, and educational signage. Activities that produce loud or prolonged noises are prohibited to prevent adverse impacts on the surrounding habitat areas.

SOME 'DID YOU KNOWS' ABOUT ESTATE PLANNING

If you've done any estate planning, or even if you're just familiar with it, you probably know the basics — that is, a comprehensive estate plan can help you pass on assets to your family while also achieving other goals, such as designating someone to take care of your affairs if you become unable to do so. But you may not know about some other estate-planning issues that could prove important in your life:

- Power of attorney for students Children heading off to college may be considered legal adults in many states. Consequently, you, as a parent, may not have any control over medical treatment if your child faces a sudden, serious illness or is involved in an accident. Instead, a doctor who doesn't know your child or your family may decide on a course of action of which you might not approve. To help prevent this, you may want to have your college student sign a medical power of attorney form, which will allow you to make decisions on your child's behalf if doctors don't think your child can make those choices. You might also want to combine the medical power of attorney with an advance health care directive or living will, which lets you specify actions you do or don't want to happen. In any case, consult with your legal advisor before taking any of these steps.
- Community property versus common law Not all states treat married couples' possessions equally. If you live in a community property state, the property you acquire during your marriage is generally considered to be owned in equal halves by each spouse, with some exceptions. But if you live in a common law state, the property you obtain while you're married is not automatically owned by both spouses. In these states, if you buy some property, you own it, unless you decide to put it in the name of yourself and your spouse.
- This doesn't necessarily mean, however, that your spouse has no rights, because common law states typically have rules that guard surviving spouses from being disinherited. But here's the key point: If you move from a community property state to a common law state, or vice versa, you might not want to assume that your and your spouse's property ownership situations will remain the same. Consequently, if you do move, you may want to consult an estate-planning attorney in your new state to determine where you stand.
- Pet trusts You always strive to take good care of your pets. But what might happen to them if you become incapacitated in some way? Unless you have a close family member or friend who's willing to take over care for your pet, you might want to consider setting up a pet trust, which can take effect either during your lifetime or after you pass away. A trustee typically will make payments to the caregiver you've designated for your pet, with payments continuing for the pet's lifetime or a set number of years. Again, an estate-planning attorney can help you with this arrangement.

Estate planning certainly involves the big-picture issue of leaving a legacy to the next generation. But the issues we've discussed can also be meaningful to you, so you'll want to address them properly.

TRASH TALK-HOSTING A NO-WASTE PARTY

With Memorial Day, Father's Day, Graduation, and Independence Day all coming up, chances are you will soon be hosting or attending a celebration. Please plan to reduce the amount of waste created.

If you're responsible for food or beverages:

• Avoid providing more than necessary and have a plan for distributing leftovers. Consider asking guests to bring reusable containers to fill.



If you're giving a gift:

- Avoid greeting cards and wrap that can't be reused or recycled. Cards and wrap with foil, glitter, and similar adornments cannot be
- Serve foods that don't require utensils and maybe not even a plate. Tacos, hot dogs, hamburgers, egg rolls, pizza, corn on the cob, watermelon, grapes, and cupcakes are great examples.
- Serve beverages and condiments from bulk containers.
- If plates, cups, and utensils are needed, plan to use reusables not disposables. Bring them from home, have guests bring their own, or rent them.

If you're decorating:

- Utilize tablecloths and napkins that are washable/reusable.
- Display centerpieces that guests will want to take home, can be reused, or are easily recycled or composted. Potted plants, flowers/greenery, and photos printed on recyclable paper are good ideas.
- Say no to balloons, confetti, glitter, or any plastic decorations.
- Provide well-labeled collection bins for recyclables, compostables, and garbage. Locate them side by side so one is as easy to find as another. Ask guests to please use them correctly. Make sure you set a good example by using them correctly yourself.
- Provide a collection area for dirty reusable plates, cups, and utensils. Ideally, this should be near the collection bins mentioned above.


