SILVERSPOT NURSERY SCHOOL: CULTIVATING YOUNG MINDS AND BUILDING A LASTING COMMUNITY

Silverspot Nursery School

It had been many years since I walked through the doors of Silverspot Co-op Nursery School, and as I poked around, I realized it was almost the same as I left it. Memories came flooding back of shaving cream art and Magna-Tiles. My first real job was as an aide at Silverspot, working shifts for parents and, during the summers, working every day in the classroom. Here, I learned to face paint, practicing my skills on many eager volunteers. Working at Silverspot allowed me to create a massive face painting and babysitting business, and even though I had no kids of my own, I became very much a part of the Silverspot community and a bonus member of families across Brisbane and San Francisco. I still face paint today.

My "kids" are now the age I was when I first met them, and the cycle continues as soon enough, I will be a Silverspot parent myself. Sharing the Silverspot story is a privilege, as this environment profoundly shaped my young adulthood.

A Unique Cooperative Preschool Experience

Silverspot Nursery School offers a unique and nurturing environment where learning is fostered, children blossom, and parents connect. Established in 2003 by a group of dedicated parents, and with the support of the Brisbane City Council, Silverspot takes its name from the Callippe Silverspot Butterfly, a protected species of San Bruno Mountain.

Silverspot is a non-profit cooperative preschool, licensed from the State of California Department of Social Services (Lic. #414001706), where the magic lies in the concept of "co-op." Here, the magic lies in a village raising children together. Families are active participants at school, not just spectators. They share in planning, operations, and daily activities, fostering a sense of ownership and investment in all children. This unique approach strengthens the community and creates long-lasting bonds. Children develop supportive relationships with adults beyond their parents while parents meet, socialize, and build a supportive network.

Under the guidance of certified preschool teach-

ers, members participate in the daily program once a week for a four-hour shift. Those unable to work a school shift can pay another member to work their weekly shifts or pay a higher tuition. Parents also contribute through a school job with positions like grant writer, maintenance supervisor, dry goods purchaser, board member, fundraising, etc. Families also volunteer throughout the year at maintenance days, fundraising events, etc. The board holds general membership meetings eight times a year, where parents have dinner as a community and take turns co-hosting.

Learning Through Play: A Curriculum for Young Minds

Credentialed teachers design a curriculum around play-based learning. With a 1:5 student-to-teacher ratio, children receive personalized attention while exploring the world through exploration and interaction. Art, science, singing, and puzzles become avenues for

I was honored to be a panelist at the ninth event in the Peninsula Family Service (PFS) Thought Leader Series with the theme of Overcoming the Epidemic of Loneliness: A Community Challenge Wednesday, April 3 following San Mateo County being the first in the nation to declare loneliness a public health crisis in January.

isolation like never before that I imagine will be a model for the Bay Area, state and even the nation to follow.

We know that loneliness is detrimental to the mental and physical wellness of many people of all ages and our efforts in the county have been applauded by the U.S. Surgeon General Dr. Vivek Murthy who last year identified loneliness in the United States as an epidemic. Although I'm not an expert on loneliness others are and I see it as my mission to uplift their work and fight for the resources necessary to help all of us overcome loneliness.

This thought leader event brought together experts including UCSF professor of Geriatrics Dr. Carla Perissinotto, Peninsula Family Service CEO Heather Cleary, Peninsula Health Care District CEO Ana Pulido and UCSF assistant professor of Medicine Dr. Ashwin Kotwal to

discuss the challenges we face related to loneliness and solutions to overcome loneliness and the issues that relate to it.

In other news: The county was proud to present an honorary resolution to the longtime Director of Aging and Adult Services Lisa Mancini at a retirement party March 21. The work she did at Aging and Adult Services, for the Commissions on Aging and Disabilities has been phenomenal and impacted thousands of lives over her 25 years with the county.

I remember my first year in office in 2017 when we were exploring the Age-Friendly Cities concept and how to bring it to the county. Mancini helped our office get the concept off the ground.

And now 7 years later most cities in the county

including Brisbane are now certified Age-friendly by the World Health Organization This initiative will continue to address the pressing needs of older adults and create environments in every city to be more welcoming to our rapidly aging population.

roads on Visitacion Avenue, and a new state law impacting crosswalk safety.

Addressing Recent Fires

Our firefighters displayed courage and skill in battling two fires on Industrial Way in late March. The first, a large commercial fire on the evening of March 23rd, engulfed a 20,000-square-foot building previously occupied by the Lazzari Fuel Company. The timber framed building was unfortunately destroyed. Thankfully, there were no injuries to firefighters or the public. The cause is under investigation, and anyone with information is urged to contact the North County Fire Authority at 650-991-8138.

The second fire, a vegetation fire near the original blaze on March 24th, was swiftly contained by firefighters. This fire burned approximately half an acre but did not damage any other property.

These incidents serve as a stark reminder of the importance of fire safety. I encourage residents to visit the National Fire Protection Association website (<https://www.nfpa.org/en>) for fire safety tips and resources.

Investing in Our Future: The Capital Projects Charge

The capital projects charge on your water bill funds critical upgrades to our water and sewer systems. These investments ensure reliable service, protect public health, and safeguard us during emergencies like wildfires.

Recent projects include improved water pressure for fire protection in central Brisbane, and an upcoming study to minimize excess water entering our sewer system.

On the horizon, we plan to upgrade the Glen Park Way pump station and replace aging water meters with advanced metering infrastructure. This new technology will not only improve efficiency and reduce costs but also empower residents to monitor water usage in real-time, helping to identify leaks and save money.

By continuing to invest in our infrastructure, we are building a stronger, more resilient Brisbane for generations to come.

Smoother Roads on Visitacion Avenue

Many of you have likely noticed the recently completed repaving project on Visitacion Avenue, stretching from San Francisco/San Bruno all the way up to San Benito Road. This project, completed in two phases – Upper Visitacion in November and Lower Visitacion in March – addressed significant wear on the road surface, including cracks, potholes, and faded striping.

The project was funded through a combination of state Gas Tax and San Mateo County Sales Tax revenues for road maintenance, along with the Road Maintenance and Rehabilitation Account established by Senate Bill 1 in 2017.

Public Works staff conducted outreach to businesses and residents before each phase of construction, ensuring everyone was aware of the upcoming road closures and parking restrictions. Thanks to their cooperation, the project went smoothly and residents now enjoy a smoother, safer road.


Enhancing Pedestrian Safety with AB413

In October 2023, California Assembly Bill 413 was signed into law. This new law, taking effect in January 2025, aims to improve pedestrian and bicycle safety near crosswalks by prohibiting parking or stopping vehicles within 20 feet of the crosswalk on the approaching side of the road. This practice, known as "daylighting," increases visibility for drivers and pedestrians alike.

The law applies to both marked and unmarked crosswalks, with some exceptions. Locations with curb extensions or "bulb-outs" require a slightly smaller 15-foot buffer. Local jurisdictions have some flexibility in specific situations, but these locations must be clearly marked. Throughout 2024, warnings will be issued for non-compliance, with citations starting in 2025.

Public Works staff, collaborating with the Complete Streets Safety Committee, is currently identifying crosswalks that require adjustments to striping or parking restrictions to comply with the new law. As existing parking spaces are removed, the city will conduct outreach to inform residents, visitors, and businesses. This outreach effort began with the recent repaving of Lower Visitacion Avenue, where signs were placed in newly removed parking spots to explain the upcoming law.

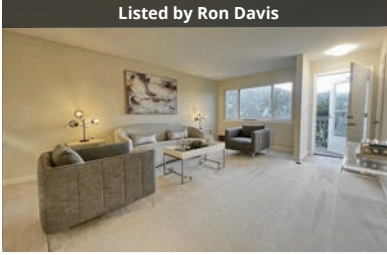

TRASH TALK—EARTH DAY EVERY DAY



You can add a subpanel that draws power from the main electrical service while freeing up additional space to connect more circuits. You can also make use of circuit splitters, downsize existing breakers, or connect new fixtures to existing circuits that are loaded at less than their capacity. As always, consult with a licensed electrician and obtain municipal permits before rewiring your home.

Replacing old service panel for safety reasons

Electric service panels that are more than 40 years old might not be code compliant and may increase the risk of fire. If the panel must be replaced for safety reasons, consider whether it's necessary to proceed with a service upgrade. Some of the options discussed above make it possible to avoid a service upgrade while adding new equipment or freeing up additional breaker slots can also help you replace an old 100-amp service panel with a new, safer one.

In addition to avoiding electric wiring upgrades, Peninsula Clean Energy also offers an array of rebates and other financial incentives to help with the switch from gas to electric. ELECTRIFY YOUR HOME WITHOUT COSTLY SERVICE UPGRADES

Families living in older, single-family homes sometimes wonder if they need to take on the costly task of upgrading their electrical wiring when switching away from gas for cooking, heating, and other household needs. The good news is, in many cases, you can enjoy the benefits of an electrified home without spending money on a new electric service panel. This is true even if your home has an older 100-amp service panel, which provides half of the maximum capacity as the 200-amp panels found in many newer homes.

Home Electricity Facts

When is the last time you looked up the maximum electric current used in your home at any given time? The team at Peninsula Clean Energy (PCE) did just that, analyzing energy usage in more than 100,000 single-family homes in San Mateo County and Los Banos. According to Blake Herrschaft, PCE's building electrification programs manager, 99 percent of homes never draw more than 100 amps, including homes that are all-electric. In fact, four out of every five homes never top 40 amps.

This is because the maximum electrical current (measured in Amps) is not typically reached, as all your electric appliances are rarely turned on simultaneously. And while it's possible, it's unlikely that you will use everything in your home

that may run on electricity—the space heater and water heater, the clothes dryer, the kitchen stove, and the electric vehicle charger—simultaneously.

Let's consider three reasons why you might consider upgrading your electric service panel. In each case, we will show some alternatives that can help save you time and money.

Adding new equipment

Adding relatively inexpensive equipment such as a circuit splitter can help you avoid a far-more costly service panel upgrade if you find yourself on track to exceed the capacity of your 100-amp panel while electrifying your home or preparing for an electric vehicle.

A circuit splitter allows two devices to share a single circuit, while a circuit pauser can disconnect one device when household current gets too high. A smart panel can also manage various circuits all at once. You can also look for these low-power equipment to achieve your goals for electrification without needing to upgrade above 100-amp service.

No space for more circuit breakers

There are electrical capacity limits and then there are physical limits. A 100-amp service panel might have slots for up to 20 circuit breakers. Let's say all the slots are taken. Now what? While you can double the number of breaker slots by upgrading to a 200-amp panel, consider less expensive options first.

The following article comes from the *Brisbane Byline*, a 1950's weekly paper with handwritten ads and front page. The paper was produced by Warren and Gladys Reece and was available for purchase at Laing's Variety, The Fountain of Youth, Les's Market, The Brisbane Liquor and Delicatessen Store, and Herbert's Store. Newsboys also sold copies for 10 cents or you could opt-in for home delivery for 40 cents a month or \$1.50 for the whole year. If you wanted the paper mailed, copies were 50 cents a month or \$5 a year.

NEW CHOICES FOR BUSINESS OWNERS

If you own a business and you offer a 401(k) or similar retirement plan to your employees, you'll want to stay current on the various changes affecting these types of accounts. And in 2024, you may find some interesting new developments to consider.

These changes are part of the SECURE 2.0 Act, enacted at the end of 2022. And while some parts of the law went into effect in 2023 — such as the new tax credit for employer contributions to start-up retirement plans with 100 or fewer employees — others were only enacted this year.

Here are some of these changes that may interest you:

- **New "starter" 401(k)/403(b)** – If you haven't already established a retirement plan, you can now offer a "starter" 401(k) or "safe harbor" 403(b) plan to employees who meet age and service requirements. These plans have lower contribution limits (\$6,000 per year, or \$7,000 for those 50 or older) than a typical 401(k) or 403(b) and employers can't make matching or nonelective contributions. These plans are low-cost and easy to administer but the credit for employer contributions doesn't apply, as these contributions aren't allowed, and since start-up costs are low, the tax credit for these costs will be correspondingly lower than they'd be for a full-scale 401(k) plan.

- **Matches for student loan payments** – It's not easy for young employees to save for retirement and pay back student loans. To help address this problem, Congress included a provision in Secure 2.0 that allows employers the option to provide matching contributions to employees' retirement plans (401(k), 403(b), 457(b) and SIMPLE IRAs) when these employees make qualified student loan payments. Of course, if you offer this match for student loan payments, your costs will likely increase, although these matching contributions are tax deductible. In any case, you may want to balance any additional expense with the potential benefit of attracting and retaining employees, particularly those who have recently graduated from college.

- **401(k) eligibility for part-time employees** – Part-time employees who are at least 21 years old and have at least 500 hours of service in three consecutive years must now be eligible to contribute to an existing 401(k) plan. The inclusion of part-time employees could lead to higher business expenses for you, depending on the amount of contributions you may make to employees' plans. Again, though, you'd be offering a benefit that could be attractive to quality part-time employees.

- **Emergency savings account** – Many people, especially those who don't earn high incomes, have trouble building up emergency funds they can tap for unexpected costs, such as a major home or car repair or large medical expenses. Now, if you offer a 401(k), 403(b) or 457(b) plan, you can include a pension-linked emergency savings account (PLESA) that allows non-highly compensated employees to save up to \$2,500, a figure that will be indexed for inflation in the future. PLESA allows for tax-free monthly withdrawals without incurring a 10% tax penalty. PLESA contributions are made on an after-tax (Roth) basis and must be matched at the same rate as other employee contributions.

You may want to consult with your tax and financial professionals to determine how these changes may affect what you want to do with your retirement plan. The more you know, the better your decisions likely will be.

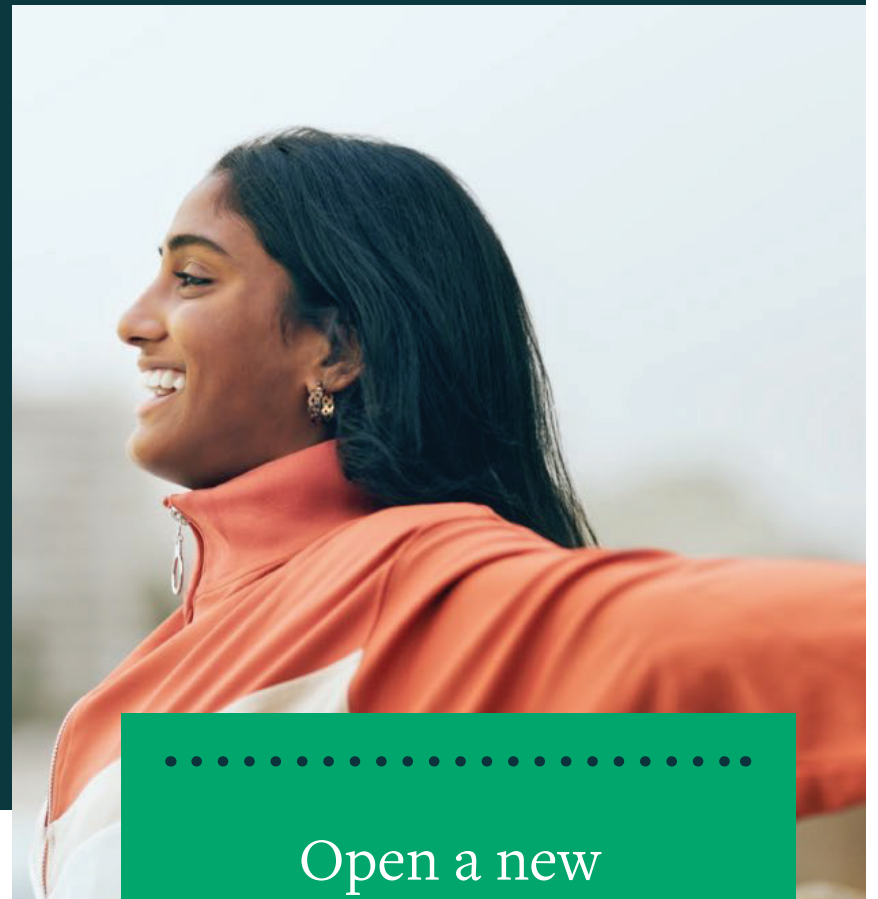
Western Days Parade:
