Remember this nursery rhyme?

First star I see tonight;

Have the wish I wish tonight.*

Could be that kids will have to travel hundreds of miles to see some real stars. In the last ten

With new Omicron variants of COVID-19 spreading through the community, it is recommended for everyone 12 and older to get the new bivalent booster, which replaces previous booster recommendations.

But according to our county Health System, only 6 percent or 43,429 county residents have

years, most of the real stars have disappeared from our sky over Brisbane. And it's the same story all across the country.

The saturation of light in our cities has nearly doubled every decade since the 1970's. Look at a satellite view of earth at night and you'll see blisters of white light becoming more interconnected. Once that light hits the atmosphere and scatters, it obliterates the stars above.

Crime, as you might expect, drives the quest for more light. But when a number of cities and towns in the U.S. and Europe turned off some lights to save energy, many reported a drop in crime.

Despite numerous studies showing that increased lighting doesn't reduce crime, we cling to the belief that the more light we have, the safer we'll be.

Looking at Brisbane at night, you'll see what I mean. LED lights on homes illuminate the entire mountainside and much of the lower streets of Central Brisbane. Businesses are also over-illuminating buildings and parking lots with poorly-aimed lights.

All this light spill is inadvertently broadcast to neighbors, or goes skyward, eliminating our view of stars in the night sky.

But worse yet, artificial light can affect human physiology and throw us out of balance. New studies show that even moderate light exposure during sleep can harm the heart and increase blood insulin levels.

The pervasive use of artificial lighting also disrupts animals, changing their behavior and patterns of waking, sleeping, and activity. Nocturnal animals often become disoriented; bird migration patterns are altered. Some species are more subject to predators and forced to decrease their foraging. Artificial lights confuse reproduction cycles of birds, fish, insects, plants as well as humans.

The disruption of our natural biological rhythms subjects us to constant stress. Entire ecosystems that took billions of years to develop are being disrupted.

What can be done?

The problem has become so acute that several large and small cities have passed Dark Skies Ordinances to reduce light pollution. Flagstaff, Arizona was the first U.S. city to enact an outdoor lighting ordinance way back in 1958; Pittsburgh recently adopted one in 2021.

Downward-pointed lighting fixtures with shields on the sides can often prevent light from inadvertently spilling to neighbors or going skyward. But lighting from a second story might need further alteration to reduce flooding the area below.

Want to help protect our night sky from light pollution? You can conduct a lighting assessment of your house or building to evaluate the impact of your lights. The International Dark-Sky Association has a step-by-step guide you'll find at: idsw.darksky.org/dark-sky-friendly-home. They also have suggestions on lighting fixtures.

A few simple changes and you'll be doing your part to restore the stars over Brisbane...the real ones. Let's ensure our kids get to see a true starry sky.

received the updated COVID-19 booster. With that in mind, the county is offering the updated booster at clinics throughout the county and I encourage you all to take that shot to keep your family protected from this still circulating disease.

Broader health care systems – primary care practices and pharmacies across the county – are also offering the updated booster. At many pharmacy locations, you can make an appointment same day or next day, and at some locations flu shots can be obtained during the same visit.

TIPS (NO TRICKS) FOR A LOW-WASTE HALLOWEEN

Q: Any suggestions for how to keep Halloween-related waste to a minimum?

A: Yes! Here are just a few:

- If you're looking for a costume, avoid buying anything new or poorly made. Create an outfit with items you already have, can borrow from a friend or family member, or buy from a secondhand store. Have a costume from last year that no longer fits or suits your taste? Ask around to see if someone you know would like to swap.

- When decorating your home or office, select reusable items or pumpkins, gourds, and cornstalks that are unadorned with glue, paint, or glitter and can be composted after the holidays. If your decorations require power, make sure they plug in. If they require batteries, invest in reusables.

- If you'll be giving out candy, avoid goodies that are individually wrapped in plastic. Choose treats like Whoppers, Dots, and Milk Duds that are packaged in compostable paper boxes. And, if you have leftover candy, consider freezing it to use for upcoming holiday baking or gingerbread house building. The internet is full of recipes for leftover candy!

BRISBANE School District News**BSD FREE/REDUCED LUNCH APPLICATION EXPLAINED**By: **RONAN COLLVER**, Brisbane School District Superintendent, rcollver@brisbanesd.org

California has implemented a Universal School Meals program that provides a free breakfast snack and a free school lunch for every public school child that wants one. Many parents question why the District is still asking them to complete a Free/Reduced Lunch Application when the meals are already free to all students.

Even though the Free/Reduced application has no bearing on their child's meal, families may qualify other benefits. These include:

- SamTrans is providing a free, unlimited-ride youth bus pass for every child who qualifies as free or reduced. The pass is good through August 2023.
- Families who qualify will receive Pandemic EBT (P-EBT) cards for each child in their household.

P-EBT cards are debit cards that can be used almost anywhere.

Last year, the amount in each card was \$250. (P-EBT cards)

- Students who qualify for Free meals will have a \$500 college savings account started in their name (CalKids)

The impact on the District of having more children qualify for free/reduced-price meals is that we will receive additional funds from the state ("LCFF Supplemental Funds") and may qualify for additional grants and programs.

The District will receive reimbursement from the National School Lunch Program (US Dept of Agriculture) for every meal served to a student who qualifies for free or reduced-price meals, whereas, California will reimburse the district for the "paid" students.

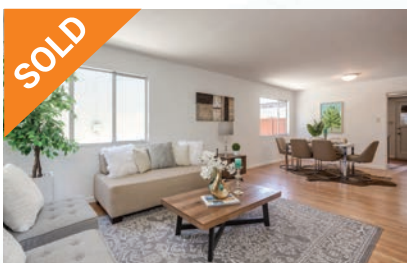

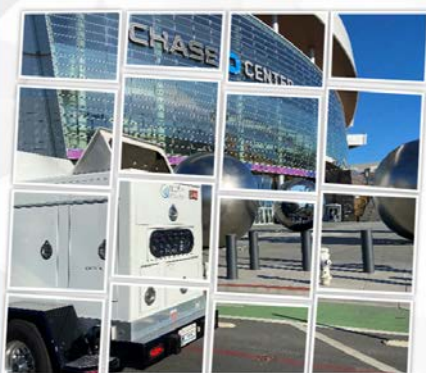

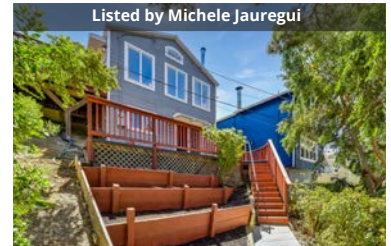
